

# **Reduce Risks from Invasive Species Coalition Award Nomination Form**

## **Award Category:**

## **Outstanding Leadership by an Elected Official**

Awarded to an elected official at the Federal, State or Local levels who has made a significant contribution to reducing the environmental or economic risks posed by invasive species.

# **Outstanding Local Government Agency Achievement**

Awarded to a local government employee and agency that has made a significant contribution to reducing the environmental or economic risks posed by invasive species.

# **Outstanding State Government Agency Achievement**

Awarded to a State government employee and agency that has made a significant contribution to reducing the environmental or economic risks posed by invasive species.

#### **Outstanding Federal Government Agency Achievement**

Awarded to a federal government employee and agency that has made a significant contribution to reducing the environmental and economic risks posed by invasive species.

#### **Outstanding Private Sector Achievement**

Awarded to a private sector company that has introduced a product or service that has the potential to make a significant contribution to reducing the environmental and economic risks posed by invasive species.

#### **Outstanding Volunteer Achievement**

Awarded to a person or non-profit organization that has made a significant contribution to reducing the environmental and economic risks posed by invasive species in their community.

#### **Outstanding Innovation**

Awarded to a person or organization that has demonstrated a technology, organizational, or operational innovation achieving or is likely to achieve an important reduction in environmental or economic threats from invasive species.

### **Award Process:**

The RRISC Awards Committee will make a recommendation to the RRISC Board of Directors for one or more awards in each category.
